2. The field of selection and the educational qualifications as per provisions of Recruitment Rules along with duties attached to the said post are as under:

Eligibility for Deputation:

Officers under the Central Government:

- (a) (i) Holding analogous posts on regular basis in the parent cadre/Department; OR
- (ii) With three years' service in the grade rendered after appointment thereto on regular basis in Level-7 (Rs. 44900-142400) in the pay matrix or equivalent in the parent cadre/Department; and
- (b) possessing the following educational qualifications and experience as prescribed for direct recruits:

Essential: Bachelors Degree of a recognized University or equivalent.

(ii) Five years' experience of administration, Accounts and establishment work in Government offices at a supervisory level.

Desirable: Knowledge of Government Rules and Regulations.

Note 1.- Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note 2.- The qualification (s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in case of candidates belonging to scheduled castes or scheduled tribes, if at any stage of selection. The Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

Note: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not to exceed three years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

Duties, attached to the post:-Administrative Officer is responsible for looking after all matters concerning Administration, Establishment and accounts/Finance etc. i.e.

- Appointments, discharge quasi-permanency, probation clearance of group 'B', 'C' employees and allied correspondence.
- Engagement of Daily paid labourers, implementation of labour laws.
- Promotions, transfers, deputation of employees.
- Maintenance of confidential reports dossiers of all officials.
- Verification of character and antecedents of employees.
- · Purchase of stores including medicines, seeds and spare parts for vehicles.
- Member of certain committees like Purchase Committee, Auction Committee etc.
- In all other Administrative and Establishment matters, he is required to assist the Director.
- 3. The Officer selected on deputation, may elect to draw either the pay in the Level (in the Pay Matrix)/Scale of pay of deputation post or his/her basic pay in the parent cadre plus Deputation (Duty) Allowance thereon plus Personal Pay, if any. The other service conditions of the officer selected on deputation would be governed by the rules and regulations issued by the concerned nodal departments of Central Government.
- 4. Application in triplicate, in the enclosed Performa along with the complete up-to-date CR dossiers (last five years) of officers who are willing to be considered and can be spared in the event of their selection, may be sent to this Department. While forwarding applications, it may be verified and certified that particulars furnished by the candidates are correct and that no vigilance case is either pending or contemplated against them and their integrity is beyond doubt. A statement on imposition of penalty during the last 10 years may also be provided. A cadre clearance certificate in respect of candidate may also be forwarded to this Department.
- 5. Applications received after the due date or found incomplete will not be considered. Applications should reach this Department through proper channel within 60 days from the date of publication of advertisement to the following address:
