**Sub.: Request for One-Time Relaxation for Transfer to Choice Station- Reg.**

Respected Sir,

I am writing this letter on behalf of the All India Civil Accounts Officers (Sr. AOs & PAOs) Association (AICAOA) to bring your kind attention to consider "One Time Relaxation" for transfer to the choice station on completion of half of the tenure to those Sr. Accounts Officers who were posted on promotion/transfer under the old transfer policy before the issuance of the new Transfer Policy vide OM No. A-32014/4/2021/MF.CGA(A)/Group 'B'/Policy/HR-III/1463 dated 12<sup>th</sup> February 2024.

As discussed in the meeting with your good self on 24.10.2024, it was assured by your office that this matter would be considered positively. Furthermore, this point has also been documented in Para 2 (iv) of the Minutes of Meeting issued vide your office letter no. A-23006/2/2020-NGE-CGA/446 dated 05.11.2024.

In light of this, I sincerely request you to consider granting a "One Time Relaxation" for transfer to the choice station upon completion of half of the tenure for such Sr. AOs who were posted on promotion/transfer in the wake of the old transfer policy before the issuance of the new Transfer Policy dated 12<sup>th</sup> Feb.' 2024. If this relaxation is not provided, it will result in junior officers occupying vacancies, thereby forcing senior officers to wait for an extended period without any fault of their own.

Considering the fairness and morale of the Sr. Accounts Officers of cadre, I request your kind intervention to approve this relaxation, ensuring that senior officers are not placed at a disadvantage. Your positive consideration of this matter would be highly appreciated.
