Agenda points and decisions of NEC are as follows :</p> <p>Agenda 1: Seek legal recourse on different Cadre related issues.</p> <p>Deliberations/ Decisions of NEC: An urgent online meeting of NEC was organised on 1st May’ 2025 to discuss the recommendations of Legal Committee, AICAOA submitted to NEC vide letter no. AICAOA/Legal Committee/2025/01 dated 18.03.2025. Ms. Geetanjali, President, AICAOA and Ms. Sreemati Bhowmik, Addl. SG, AICAO informed all the present NEC members about the developments/ financial implications with reference to legal recourse on the issues/matters recommended by Legal Committee vide above referred letter.</p> <p>After due deliberations, following decisions were taken unanimously:</p> <ol style="list-style-type: none"> (i) AICAOA will send representations to Competent Authorities on pending cadre related issues. (ii) AICAOA will seek legal recourse on both the matters at earliest. (iii) AICAOA authorized all the powers to Ms. Geetanjali, President, AICAOA of this Association to represent and deal on behalf of this Association including financial implications as discussed and sign all the relevant documents/certificates etc., that are required to seek legal recourse in both the matters at earliest possible. (iv) All NEC members will provide their full co-operation in seeking legal recourse and will sign all relevant documents/ certificates as and when called for by NEC, AICAOA. (v) An online meeting with all Zonal Representatives will be organized on 04.05.2025 (Sunday) at a convenient time to brief the discussions held with CGA during meeting on 30.04.2025.
