MA No. 2529/2025 has been filed by the applicant.

2. Learned counsel for the applicant submits that the OA has been filed at the initial stage seeking a direction to the respondents to decide the pending representation. He seeks modification to the extent that not only the representations dated **25.11.2022** and **28.11.2022**, but also the latest representation dated **02.05.2025**, be directed to be considered by the respondents.

3. It is further submitted that although multiple issues have been raised in the representation, at present, the applicant confines his prayer only to the issue concerning the maintenance of the RRS.

4. Learned counsel for the respondents, on instructions, submits that they have no serious objection to the prayer made in this MA.

5. In view of the above, the MA is allowed. The order dated **16.05.2025** is modified to the extent that paragraph 5 of the said order shall now read as under:
