Chaurasia <u>Auditor</u> Rahul Butola	No. AICAOA/NEC Meeting/2025-26/187 Date: 29.09.2025 <u>MINUTES OF NEC MEETING</u> An online meeting of the “National Executive Committee Zonal Executives and some of the members” of AICAOA was held on 14th September’ 2025 at 3:30 PM on Google Meet to discuss following agenda items. Agenda-wise deliberations/ decisions of NEC are as below: 1. Reconciliation of Subscription of Members: It was informed to all present that reconciliation of subscription for the month of August’ 2025 has revealed that almost 25% members (Approx. 140 members) are not subscribing due to reasons best known to them only. The NEC and Zonal Executives along with other present members expressed their concerns over the lack of subscription by a large number of members. It was decided unanimously that NEC will share subscription reconciliation statement in AICAOA Whatsapp Group and all the NEC & Zonal Executives will reach each non-subscribing member to start their subscription. It was also decided that non-interested and long defaulters should be removed from AICAOA Whatsapp Group. 2. Feedback/ suggestions: It was decided in the meeting that the Association will collect feedback and suggestions on matters to be taken up in the court of law, service conditions of Sr. AOs, HR-related issues, grievances relating to the functioning of the NEC, and other cadre-related matters deemed fit. It was also decided that such feedback/suggestions shall be submitted from personal email IDs to the Association’s official email ID, along with supporting documents such as circulars, OMs, or any other relevant material. Members should invariably mention their name, phone number, department, and posting station to facilitate further contact, if required. All suggestions should reach the Association by 30th September, 2025. 3. Issuance of reminder Letters on different matters: It was deliberated upon and decided unanimously that AICAOA will send reminders of letter on grant of NFU, Pay Fixation on STS Level on promotion as ACA and other similar letters which have not been acted upon by authorities concerned. 4. Letter for appointment of CGA for meeting: It was decided unanimously that AICAOA will write a letter and seek appointment of CGA Maam for a team meeting to discuss different cadre related issues. 5. Any other issue with the permission of Chair : Following issues were raised during the meeting with the permission of President, AICAOA: (a) As per Agenda Point 4 of Minutes of Meeting dated 05.08.2025, issue of irregular attachment of Sr. AOs at outstation was raised and taken up during the meeting. After due deliberations, it was decided unanimously that AICAOA will collect information of such attachments through feedback/ suggestions of members and will take up accordingly.	

- (b) It was raised that many of the suggestions of AICAOA have been agreed to by O/o CGA during meeting with AICAIA on 30.04.2025 as communicated vide Para 5.2 of O/o CGA's letter no. 23011/1/2020-NGE-CGA/162 dated 3rd June' 2025. AICAOA has already requested O/o CGA to incorporate the agreed points on Transfer Policy as part and parcel of Transfer Policy by issuing a suitable OM/corrigendum vide letter no. AICAOA/NEC/2025-26/181 dated 03.07.2025. However, it has not been acted upon since yet. After due deliberations, it was decided unanimously that AICAOA will issue a reminder again for the same and will request authorities to incorporate those points in Transfer Policy.
