MINUTES OF NEC MEETING

An online meeting of the National Executive Committee of AICAOA held on 28th May' 2026 at 8:00 PM on Google Meet to discuss following Agenda Points:

Agenda 1: To deliberate upon proposed amendment in Recruitment Rules (RRs) for the post of Sr. AOs (L-10).

Deliberations: Sh. Rajeev Kumar, Finance Secretary who was assigned the charge of Member Secretary of Draft RR Committee, AICAOA presented the recommendations of Committee which was accepted unanimously by all present with some suggestions of members present. Further it was also decided by AICAOA that comments on proposed amendments on RR of Sr. AOs should be forwarded to all concerned departments i.e. Deptt. of Expenditure, Deptt. of Personnel & Training, UPSC and Deptt. of Legal Affairs.

Agenda 2: Status of Court Cases:

Deliberations: (i) Status of on-going court cases was deliberated upon and next date of hearing of these cases was informed to all present members which is as below:

(ii) It was informed to all present that AICAOA has filed a contempt petition in CAT, PB, Delhi vide CP No. 1002/2025 in the matter of OA No. 3694/2022. Since, decision is yet to be implemented, AICAOA decided unanimously to file a Caveat before the Hon'ble Delhi High Court as a precautionary measure to safeguard the interests of its members and to ensure an opportunity of hearing.

(iii) Ms. Geetanjali, President, AICAOA was authorised to represent and deal on behalf of this Association and sign all the relevant documents/certificates required for filing Caveat in Delhi High Court in the matter of O.A. No. 3694/2022 of Principal Bench, CAT, Delhi.

Agenda 3: Future course of action in the matter of (a) grant of NFU to Sr. AOs and (b) Cadre Restructuring on the lines of IA&AD.

Deliberations: It was deliberated upon that failing timely resolution of the issue; AICAOA reserves its right to seek appropriate legal recourse in both the matters having been left with no alternative remedy. After due deliberations, it was decided unanimously that AICAOA will move ahead to seek legal recourse in both the matters.

Agenda 4: Follow up with Department of Expenditure for a meeting.

Deliberations: It was decided unanimously that NEC Members who represented AICAOA during meeting with the Secretary (Expenditure) on 08.05.2026 will follow up under the leadership of President, AICAOA with officials of Department of Expenditure for further meeting as agreed upon during meeting with the Secretary (Expenditure) on 08.05.2026 and requested vide AICAOA's letter no. AICAOA/NEC/2026-27/7 dated 14.05.2026.

Agenda 5 : Any other issue with the permission of Chair:

Issue of grant of NFU to GP 5400 (PB2) to AAOs w.e.f. 01.01.2006 was raised with the permission of President, AICAOA and was deliberated upon in detail. During the meeting, concern was raised by present NEC members that NEC members at Delhi are presently heavily engaged in various organizational matters and ongoing litigation. Therefore, in order to pursue any additional case effectively, it is essential that beneficiary volunteers based in Delhi come forward to coordinate the matter with the NEC members and assist in the necessary follow-up at various stages. It was also decided to hold a specific meeting w.r.t. this matter on 30.05.2026.
