Kaushal Mishra, Secretary General informed all members with immense pleasure that the 8th Central Pay Commission (8th CPC) has been pleased to grant an appointment to AICAOA during their visit to Lucknow on 23rd June' 2026. All the members wholeheartedly congratulated the efforts of existing Draft committee of AICAOA and expressed their happiness over this historic achievement. For the first time in the history of CCAS, an association has succeeded in securing an appointment with the Committee. This milestone is a testament to the united efforts, dedication and growing recognition of AICAOA. Day by day, we are moving ahead towards greater achievements. This accomplishment reflects the Association's unwavering commitment to safeguarding and advancing the interests of the cadre. After detailed deliberations following decisions were taken unanimously: (i) Prevailing Draft 8th CPC Committee, AICAOA will continue and finalise the issues to be presented before 8th CPC during the meeting. (ii) 8th CPC has restricted the number of representatives to 3 members. Thus, Ms. Geetanjali, President, Sh. Kaushal Mishra, Secretary General and Sh. U.C. Joshi, Chairman, Legal Committee, AICAOA were nominated unanimously to represent AICAOA before 8th CPC. Ms. Geetanjali and Sh. U.C. Joshi will visit Lucknow w.e.f. 22.06.2023. <u>Agenda 2: Formation of North East Zone and East Zone:</u> Deliberations: Shri Debraj Singha Roy, Asstt. Secretary General informed all the members that he has done all the ground work for formation of North East Zone at Shillong and East Zone at Kolkata. Further, he added to visit Shillong on 9th July' 2026 and Kolkata on 13th or 14th of July' 2026. All the present members applauded the relentless efforts of Shri Roy. After due deliberations, following decisions were taken: (i) Ms. Geetanjali, President, Sh. Kaushal Mishra, Secretary General and Ms. Sreemati Bhowmik, Addl. Secretary General were nominated to visit Shillong and Kolkata during the period 09.07.2026 and 14.07.2026 and were directed to complete the formation of North East Zone and East Zone respectively.
