Delhi based members were promoted to witness the hearing at Delhi High Court at due time. <u>Agenda 2: Formation of West Zone-II:</u> Deliberations: The issue of formation of West Zone - II was already been discussed in earlier NEC meetings. Shri Amol Sule, ASG was working on this issue. During the meeting, it was informed to all the present members that Shri Amol Sule, ASG has fixed the convenient date as 23.07.2026 for the formal formation of the said Zone.
