Agenda : To finalise the venue of 3rd General Body Meeting on 25th November' 2026.

Deliberations: It was informed to all NEC members that 3rd General Body Meeting of the AICAOA has been scheduled to be held on 25th November' 2026 at Delhi as decided in the NEC Meeting dated 07.07.2026. NEC team members were exploring the suitable Venues in Delhi.
