The committee submitted its recommendations to NEC, AICAOA vide letter No. AICAOA/NEC/CDN-TOR/01 dated 11.08.2026 which was passed and accepted unanimously by NEC, AICAOA. After due deliberations a Committee headed by Sh. Mahesh Kumar, Vice President along-with the following members was constituted to frame guidelines for the Co-ordination (CDN) Committee of AICAOA: 1. Kaushal Mishra, Ex-officio Member <u>Agenda 2: Formation of South Zone-I and South Zone-II Zonal Committees:</u> Deliberations: The issue of formation of South Zone - I (Hqrs. at Hyderabad) and South Zone-II (Hqrs. at Chennai) was in considerations of NEC since long back. NEC was working hard for formation of both zones before forth coming GBM of AICAOA scheduled in November'26. Now, the dates for holding meeting for formation of both zones have been fixed in consultation with respective members of both zones. NEC representatives have been invited for the same on 18th September'26 at Chennai and on 21st September'26 at Hyderabad to witness the election process and conduct it smoothly.
