**Subject: Transfer/posting of AOs/SrAOs who are posted outside their home station and has given their representation requesting for transfer back to their home station on various grounds.**

**Respected Sir,**

The undersigned is directed by the National Executive Committee, AICAOA to invite your kind attention to the Office Order No. 683 dated 17<sup>th</sup> March, 2023 vide which 81 AAOs have been promoted as Accounts Officer. While the long awaited promotion order brought a sigh of relief to the AAOs who were anxiously waiting for their promotion, but on the other hand, the said promotion order has created an unrest among those AOs/Sr.AOs who are posted outside and are waiting for their transfer at their home station.

It is submitted that Office of CGA vide OM No. A.32014/1/2002/MF.CGA(A)/Gr.B/Vol.III/Policy/663 dated 30<sup>th</sup> October, 2015 (copy enclosed) as amended from time to time, framed the guidelines for transfer of AAOs/AOs on promotion and on rotational basis. Since inception of the policy in 2015, it is being followed scrupulously as is evident from the following OMs issued by O/o CGA:

6. K-18002/1/2021/Promotion/MF.CGA(A)/HR-III/Part-1/664 dated 30.03.2022 and many more.

The practice besides being transparent invokes confidence of the members, as well as association that the transfers are being done on seniority basis as per transfer request. Violation and deviation of policy guidelines besides being opaque, arises questions on the conduct of administration.


With the issue of the instant promotion order, the AOs/Sr.AOs posted outside are totally disheartened and felt being treated unequal and unjust. This is an undeniable fact that AOs/Sr.AOs posted outside their home station is undergoing tough situations physically, mentally and financially. They have been posted in those station against their option at the order of CGA with the reason of non-availability of vacant post. Under these circumstances, when the existing vacant posts are filled by the juniors, it automatically arouses a feeling of being treated unequal. The officers posted outside had already represented for their transfer in their home station on various grounds viz, self medical ground, medical ground in respect of his/her family members and spouse's working station, which has also been given due consideration by DOPT.

In view of the above, the undersigned is directed by NEC, AICAOA to request your good office to consider all the representations given by the AOs/Sr.AOs who has obeyed CGA's order and posted outside before any further transfer order is issued.

Adopting a new trend by giving posting of newly promoted AOs in the same station subject to availability is definitely a positive step but the same will be more justified if the seniors posted outside are transferred back to their home station and then the juniors are adjusted to the extent vacancy is available.

Expecting a positive response from your end.
