Sir,

To.

First of all, I would like to appreciate and congratulate your office for issuing long awaited promotion orders of 725 AAO (C) CBT 2022 passed officials under your leadership.

Further, I have been directed by NEC of AICAOA to draw your attention on hardship and adversities being faced by AOs and Sr. AOs posted outside their home/choice station and awaiting transfer. I would like to highlight the fact that earlier to transfer/promotion orders dated 17.03.2023 issued by your office, AOs/ Sr. AOs were being transferred to their home/ choice station on 'Own Request Ground' based on existing transfer policy only. The same transfer policy still exists but its interpretation has now been changed as is evident from your office order dated 17.03.2023. The new trend of interpretation has put transfer awaiting officers to a grave demoralizing situation.

As a responsible association making a bridge between staff side and official side, AICAOA raised the concern time & again vide letters dated 20.03.2023, 24.03.2023, 28.03.2023 & 24.05.2023 and requested for appointment vide letters dated 20.03.2023 and 24.03.2023 for deliberations in a congenial atmosphere to reach at a consensus. To its reply, your office vide letter dated 11.04.2023 assured to schedule a meeting soon. AICAOA is still looking forward for the same. Comments on Transfer Policy have also been submitted by AICAOA to your office within stipulated time frame. AICAOA requested vide it's letter dated 24.05.2023 for **'One Time Relaxation'** and adoption of old pattern of transfers, as was in force before issuance of order dated 17.03.2023 **i.e. Transfer on Own Request**; by the time New Transfer Policy is decided. However, no assurance received till date.

The National Executive Committee of AICAOA believes that meeting is the best and fastest way to resolve any issue after due deliberations.

You are once again requested to give us a convenient time of yours at the earliest possible as assured vide your office letter dated 11.04.2023 so that our representatives could meet and convey the grievances of aggrieved members.

Looking for a positive response from your end.
