Respected Sir,

I am writing this letter on behalf of the All India Civil Accounts Officers (Sr. AOs & PAOs) Association (AICAOA) to draw your attention to the Minutes of Meeting issued by your office vide letter no. A-23006/2/2020-NGE-CGA/446 dated 05.11.2024.

The Minutes of Meeting were considered in the NEC meeting of AICAOA held on 23.11.2024. The members of national executive who participated in the meeting on 24.10.2024 expressed disagreement with content of para 1(i) of the minutes, wherein it has been written that earlier proposal of CGA Office vide I.D. Note A-65061(55)/36/2020/Group B-CGA dated 29.10.2020 for grant of STS level to Sr. AOs on their promotion has been turned down by Deptt. of Expenditure, Ministry of Finance. Whereas, it was informed during the meeting to the official side that the above referred I.D. note dated 29.10.2020 has been filed by Deptt. of Expenditure without any specific action. This information was received by staff side through RTI reply of Deptt. of Expenditure, Ministry of Finance vide letter no. H-12019/2/2021-Ad.I dated 26.04.2024. The documentary proof of the RTI reply was handed over to the official side during the meeting itself on 24.10.2024 with the request to take up the matter with DoE and issue a reminder in this regard. Copy of the RTI reply dated 26.04.2024 is once again attached for your reference please.

It is therefore requested that point no. 1(i) of Minutes of Meeting issued by your office vide letter no. A-23006/2/2020-NGE-CGA/446 dated 05.11.2024 may be revised accordingly. Further, it is also requested that matter may be taken up with Deptt. of Expenditure for consideration of I.D. Note dated 29.10.2020 and a reminder may be issued from O/o CGA for the same.
