Subject: Non-Relieving of Senior Accounts Officers and Pay & Accounts Officers despite their transfers to their choice stations and on IMTs - Regarding.

Madam,

It has been brought to the notice of this Association that the Senior Accounts Officers/ Pay & Accounts Officers are not relieved by their respective CCAs despite their transfer orders issued by Office of the Controller General of Accounts, from one station to other station and also on Inter Ministerial Transfers at the same station.

Even though clear cut instructions were issued in the transfer orders itself for relieving of the officers, within one month, failing which these officers would be deemed to have been relieved on the expiry of the said one month period, the concerned CCAs are not relieving them on the pretext of the substitute or the other.

Shri Ashok Kumar, PAO, transferred from Health, Mumbai to I&B, Pune has not been relieved till date despite his transfer orders vide CGA Office Order No. 08/2022 dated:30th March, 2022. Shri P V S Sastry, Sr.AO, transferred from Home, Hyderabad to Finance, Hyderabad is not yet relieved and still working in Home, Hyderabad. (Office Order No. A-22013/4/2020/IMT/MF.CGA/HR-III/391 dated: 13th January, 2021)

In this regard it is once again requested to intervene in such cases immediately and to issue necessary instructions/orders to the respective Pr.CCAs/CCAs to relieve such officers immediately.
