Sub: Urgent Need to address Disparity between DAD and CCAS Cadre-Reg.

Respected Madam,

I have been directed by NEC of AICAOA to draw your attention towards a matter of great concern that pertains to the existing disparity between the Defence Accounts Department (DAD) cadre and the Central Civil Accounts Services (CCAS) Cadre. **This disparity is particularly troubling given that both are sister cadres having historical parity and share a similar nature of duties.**

As evident from the data and facts presented in the below chart, **there exists a growing gap between the treatment of Pay & Accounts Officers (PAOs) and Senior AOs within the DAD and Pay & Accounts Officers (PAOs) and Senior AOs within the CCAS cadres.** This inequality in terms of pay, allowances and status is causing significant distress among the employees of the CCAS cadre, who rightly expect fair and just treatment:

5.	Vide letter P-213 dated 08.08.2023, allowed promoted Sr. AO w.e.f. 30.11.2022 as Group 'A' (copy enclosed).	Nothing done till date	No similar action has been taken by Office of the CGA.

It is evident that PAOs and Senior AOs of Defence Accounts Department (DAD) are enjoying timely career benefits and recognition, while their counterparts in the CCAS cadre are facing a distressing situation.

The work carried out by CCAS cadre employees has grown significantly, especially in the implementation of crucial systems such as PFMS, e-Kuber, NTRP, TSA, CNA, EAT, SNA and various other PFMS modules which are vital for overseeing the flow of Government of India funds, monitors receipts and compiles the accounts. **This inequitable situation, when DAD Cadre enjoys all benefits and parallel benefits are not allowed to CCAS Cadre, is perplexing particularly when both cadres are guided by the Department of Expenditure (DoE), which acts as the nodal ministry regulating career progression and promotional avenues for both cadres.**

Further, I would like to bring to your attention the Office Memorandum F. No. 23(4)/ E.Coord/ 2020 dated 23.03.2020 (copy enclosed) issued by Ministry of Finance **which designates the expenditure functions of the government, including those of the IFD of Ministries/Departments and the Office of the Controller General of Accounts (CGA), as Essential Services during the COVID-19 pandemic.** This further underscores the critical nature of the CCAS cadre's work.

In light of the above, I respectfully request your immediate attention and intervention to address this disparity. **I request you to direct the concerned authorities to take necessary steps to ensure that the benefits and allowances enjoyed by the DAD cadre are extended to the deserving employees of the CCAS cadre as well. This will not only rectify the existing inequality but also uphold the principles of equity and justice.**



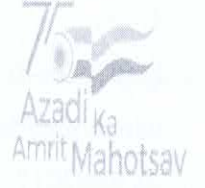

Subject: Promotion of Accounts Officers to the grade of Senior Accounts Officer.

The Competent Authority has approved promotion of 633 (Six Hundred Thirty Three) Accounts Officers to the grade of Senior Accounts Officer as per *Annexure-I* to this letter, in the level-10 of 7th CPC Pay Matrix (Pay Band-3, Rs 15600-39100 with Grade Pay Rs 5400/- pre-revised scale of 6th CPC) with immediate effect or from the date of assumption of charge of the promotional post, whichever is later.


2. Since the current promotion in the grade of Senior Accounts Officer is subject to mandatory assessment by the UPSC for induction in Group-‘A’, the same is required to be notified for the present as Group-‘B’ Gazetted in terms of the Defence Accounts Department (Senior Accounts Officer) Recruitment Rules, 2008 (as amended vide S.R.O 07 dated 16.01.2018). However, after necessary assessment for induction in Group-‘A’ by the UPSC, they will be re-classified as ‘Group-‘A’ in due course.

3. Before promoting the Accounts Officers in the grade of Senior Accounts Officer, it may please be ensured that none of the circumstances enumerated in Para-2 of the DoP&T O.M No. 22011/4/91-Estt. (A), dated 14.09.1992 have arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead considered as if, the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of Para-7 of DoP&T ibid O.M. It may also be ensured that any of the Accounts Officer, undergoing penalty, such as stoppage of increment/reduction of pay on the due date of promotion etc, is not to be promoted till the expiry of the penalty period. If any such case comes to notice before promotion of the officer, the same may please be intimated to HQrs Office immediately.

4. Further, it is also stated that in pursuance of DoP&T O.M No. 36012/11/2016-Estt. (Res-I) (Pt.II), dated 15.06.2018, the above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court of India in Special Leave Petition (C) No. 28306/2017, SLP (C) No. 30621/2011, SLP (C) No. 31288/2017 (connected to SLP (C) No. 28306/2017) and other related court cases.


5. The Part-II Office Order notifying the assumption of charge of the promotional post may please be endorsed to this HQrs Office (Admin.-II Section).





OFFICE MEMORANDUM

Subject: Functioning of Government Expenditure System during the operation of preventive measures to contain the spread of COVID-19.

Attention is invited to DOPT OM No 11013/9/2014-Estt- (A-III) Dated 22.03.2020 regarding preventive measures to contain the spread of COVID-19.

2. In the present situation, the smooth and normal functioning of the Government Expenditure System is critical to safeguard the public interest. Therefore, the expenditure functions of Government in general and the Integrated Finance Divisions (IFD) of Ministries /Departments and Office of Controller General of Accounts (CGA) in particular, are essential services. Indeed, in certain sectors, the expenditure systems may have to function more quickly than normal to cope with the emerging needs.

3. Accordingly the following clarifications, with specific reference to IFDs & CGA, are issued.

a. Absence of staff shall not be a reason for any delay or non-functioning of the payment and accounting systems.

b. Pay and Accounts Offices and other offices dealing with payments shall remain open during working hours.

c. Financial Advisors and field offices of the CGA (Pr. CCA, CCA, CA, PAO etc) shall attend office as per normal schedule to ensure coordination and supervision and shall issue suitable instructions for the presence of others as necessary to achieve these objectives.

d. The above shall be kept in view by Financial Advisors and the Office of CGA when drawing up the roster, etc as prescribed in the OM referred to above
