Subject: 1. Extraordinary delay in the matter of Transfers and Postings of Senior Accounts Officers and Pay & Accounts Officers

- 2. Change of Civil Service Board (CSB) very frequently without issuing a single transfer or posting order.
- 3. Four (4) CSBs were constituted during the last 6 months without issuing a single transfer order.
- 4. More than 250 Vacancies in the grade of Sr.AO and PAO are lying vacant unfilled for more than one year.

Respected Sir.

Your kind attention is invited to this Association's letter dated: 24th November, 2022 on the above cited subject and the following few points are brought to your kind notice for your immediate intervention in the matter so that the Officers stationed at places spread all over India will be thankful to you:

- 1. Abnormal delay in issuing general Transfer Orders, Five CSBs constituted within 6 months without any result:
 - 1.1 There is an abnormal delay in the matter of transfers and postings and the guidelines of the "Transfer Policy" of the CGA organization are not being followed in true spirit.
 - 1.2 It is further noticed that the CGA Office has not issued any general transfer orders during the last one and half years, except a few specific individual orders, which were supposed to be done on a quarterly basis.

- 1.3 On one hand more than 250 Vacancies do exist as on date and on the other hand the general rotational, inter ministry transfer orders, from presently posted station to choice of station on completion of 3 years tenure and on own request transfers and the tenure etc., are kept pending intentionally and the CGA office is directly and indirectly playing games by changing the Civil Service Board very frequently, without issuing a single transfer and posting orders for SR.AOs, PAOs and AAOs.
- 1.4 Constitution of Four (4) Civil Service Boards within 6 Months: The earlier CGA, Smt. Sonali Singh, retired and failed to constitute the CSB during her time. The Present CGA, Smt. Bharati Das, has been constituting the CSBs very frequently, without any transfer orders, every time changing the Chairman of the CSB and/or other members, as per the details given below:

- 2. Request for your personal intervention: It is the basic principle of administrative justice that an officer entrusted with a particular job has to perform his/her duties honestly, efficiently and in accordance with the rules. This AICAOA, on behalf of its members, request you to take further steps for the immediate issuance of Transfer / Posting Orders, as per the recommendations of the CSB and as per the guidelines of the Transfer / Posting Policy of CGA.
- 2.2 Undue delay in transfers and postings is causing extreme frustration among the members who are due and expecting their for transfers to their choice stations. All the members of this AICAOA are expressing their unbearable mental agony, distress and other sufferings to the officers, caused due to this extraordinary delay without any valid reasons and started blaming this Association and pressurizing this Association to know the exact reasons for the delay.
- 2.3 Request for your personal intervention: In view of the above submissions, it is requested to intervene in the matter to avoid the protracted delay in issuing the above said orders not only in the interest of the officers but also in public interest as there are so many unfilled vacancies existing at so many stations for more than one year.

A stitch in time saves nine and similarly your timely interventions saves the mental agony of all the Civil Accounts Officers posted all over India and all of us will be very thankful to your timely intervention. Expressing our sincere thanks,
