Respected Sir,

The undersigned is once again directed by the National Executive Committee, AICAOA to invite your kind attention to this Association letter referred above wherein the resentment and unrest among the member AOs waiting for their posting to their home station consequent upon issuance of promotion order of 81 AAOs to AOs vide your Office Order No. 683 dated 17th March, 2023 were conveyed.

Your attention is also invited to this Association letter dated 20th March and 24th March, 2023 wherein a meeting with your good office were sought. However, no reply from your office has been received so far. You will appreciate the fact that, any kind of problem can be solved if they are discussed and deliberated under a congenial environment. This has also been agreed to by the authorities in a meeting between the representatives of the Association and the CGA alongwith his team on 21st February, 2023.

It is further observed that the provision at Para 3(xix) of the Transfer Policy in vogue (OM dated 30.10.2015) which speaks about transfers on own request, has not been considered by the authorities while issuing the transfer/promotion orders on 17th March, 2023.

You are once again requested to give us a convenient date and time at the earliest so that the issues can be deliberated in details on views of both the side and come to a positive feasible solution and boost the morale of the members of CCAS Cadre.
