The Delegates' Session of the 1st General Body Meeting of AICAOA was held on 19th November at Convention Hall, Palika Kendra, New Delhi. The Meeting was attended by 26 members (list attached) which includes members from the newly elected NEC members and delegates from Delhi and outstation. All the members present in the meeting deliberated in detail on all the agenda points and passed resolution unanimously. Following Resolution were made during the meeting:

Agenda 1: Discussion on the issues of promotion of PAOs and SrAOs vis-à-vis the role of the individual officers. Causes for undue delay in granting promotions in the cadre. Future course of action to be taken by the individual officers and the AICAOA.

Resolutions taken:

- i. Resolved to go ahead for filing court case and authorised Mr. U.C. Joshi to take initiative in this regard with the assistance of Shri Kaushal Mishra, Vice President.
- ii. Simultaneously, request all members to submit representation to authorities seeking promotion.
- iii. Letters to be written to CGA, DOPT, DoE simultaneously by the Association.
- iv. Impress upon the members to file grievances on CPGRAM.

Agenda 2: Grant of Group A Status to the post of Senior Accounts Officer and attendant benefits, consultation with UPSC and DoPT and need for amendment Recruitment Rules of the posts of Sr.AO and ICAS Group A.

Resolutions taken:

- i. Resolved to write a letter to Cabinet Secretariat endorsing a copy to O/o CGA requesting highlighting discrepancies in the cadre and requesting for
- a. early issuance of notification regarding granting Gr. 'A' status to Sr.AOs
- b. finalisation of Recruitment Rules of Sr.AO
- c. granting attendant benefits.
- ii. Amendments in the RRs of ICAS was also felt necessary to give a clear distinction between Sr.AO and ACA, both classified under Level 10 Group 'A'.

Agenda 3: Discussion on Board of Arbitration for parity with Assistants.

Resolutions taken:

Resolved that Secretary General/President of AICAOA may ask for documents/informations relating to arbitration and thereafter approach Secretary DOPT for early implementation of Board of Arbitration by giving parity with CSS.

Agenda 4: Status and future course of Action on the Merger of the posts of PAO and Sr.AO. *Resolutions taken:*

- i. Wait for the response from D/o Expenditure
- ii. If Merger is denied, will fight for promotion of Sr.AOs at Level-11
- iii. If merged, then we should move to court for getting the benefit retrospectively.

Agenda 5: What next after the post of Senior Accounts Officer and the natural justice policy of "One Level- One Post" and the hierarchy above the post of Sr.AO.

Resolutions taken:

- i. Resolved that AICAOA would write to DOPT requesting to intervene in the matter of cadre of Sr.AOs.
- ii. Also resolved that with the policy of 'One Level One Post', Association will demand for promotion of Sr.AOs as Dy.CA (Level -11)

Agenda 6: Analysis of the current active membership vis-a-vis enrolled membership in the recent past and non-deduction of membership subscription by some members. Analyzing the reasons for non-deduction of subscription by members and solutions for the subsequent deduction of membership subscription of AICAOA.

Resolutions taken:

- i. Resolved to write letters to DDOs for ensuring deduction of subscription
- ii. Also resolved to increase the membership to 30% within 3 months.

Agenda 7: Discussion and Identification of issues on which the AICAOA can file CAT case(s).

Agenda 8: Discussion on the problems faced by members as per the existing Transfer and Posting Policy of PAOs & Sr. AOs on Promotion and request transfers etc., and vis-a-vis Role and functioning of CSB.

Resolutions taken:

Resolved that the Association should take up the issue with the authority highlighting the following points

- a) Voices of those transferred outside their home-station should be heard on priority.
- b) Option sought should match with the vacancy shown. In case of any change in vacancy position, the same should be brought to the notice of the officers who are asked to exercise their option to select station for posting
- c) For better transparency, quarterly vacancy should be published in the website.
