### **Minutes of Meeting**

A meeting of Legal Committee was held under the chairpersonship of Shri U.C. Joshi, on 16<sup>th</sup> February, 2023 (Thursday) at 08:00 pm to briefly discuss the following issues:

1. Future strategy relating to present court cases i.e. promotion of PAO to Sr.AO and Cadre Review.
2. Meaningful utilisation of manpower resources, so as to avoid future fiasco.


At the outset, Shri U.C. Joshi updated about the hearing (heard on 14<sup>th</sup> February, 2023) of our case on Cadre Review (OA No. 192 of 2023). He informed that the Respondents had changed their lawyer and that their lawyer prayed for some time and consequently, he was granted a week's time. The next date of hearing is now on 21<sup>st</sup> February, 2023 (Tuesday). Thereafter, Shri Joshi expressed his concern about attending hearings in the court and meeting the lawyer as and when required. He added that this will show the strength of the Association and involvement of each member for the cases and thus boost the morale of the lawyer, enabling him to deliver his best. For this, he put forward the following proposal before the committee members for deliberations and approval thereafter:

1. Prepare a roaster who could attend the hearings and visit lawyer in turn.
2. Keep a fund for meeting petty expenses relating to the court cases.

After detailed deliberations on the above, following resolution has been made by the Committee with voice vote:

- (i) **Committee proposes to take the approval of NEC** to maintain a fund in form of an **imprest of ₹ 5000/-** at the disposal of Shri Uttam Biswas for meeting the following expenses:
  - a) Occasional out of pocket expenses for Munshi of the lawyer as and when directed by the Chairman not more than **₹ 1,000/-** at a time.
  - b) Tea and light snacks during visit to the court room on hearing dates/chamber of advocate by the member not more than **₹ 500/-** per visit.
  - c) Expenditure towards any documentation on actual basis.
- (ii) Members of the Committee present in the meeting resolved that **at least one member from Legal Committee** (who is well conversant with the cases filed) **and one from NEC** alongwith any other member, should attend hearings of the court cases filed by this Association.

The meeting was ended with thanx to the Chair.
