# **Minutes of Meeting**

An emergency meeting of Legal Committee was held under the chairpersonship of Shri U.C. Joshi, on 22<sup>nd</sup> January, 2023 (Sunday) at 08:00 pm to discuss the following issues:

- 1. To take a decision regarding issue of letter to PM/FM conveying grievances of CCAS cadre.
- 2. To apprise the Committee about the OA filed for Cadre Review in the CAT.

#### Agenda No. 1

At the outset, Shri U.C. Joshi clarified that the agenda of the meeting is to decide the advice that is to be rendered to the NEC regarding issue of letters to PM/FM on the matters relating to promotion of AOs to Sr.AOs and Cadre Review of CCAS. Thereafter, it is the NEC to decide whether to go with the advice of Legal Committee or not.

Shri U.C. Joshi proposed to advise the NEC the following:

- 1. Restrain approaching any other authority on the issues which are sub-judice as Court is the last resort for seeking justice. He alarmed that any such action may have adverse effect on the cases filed by the Association. All the members present in the meeting unanimously agreed to this.
- 2. NEC should act as per CCS (RSA) Rules 1983.
- 3. There should be a defined protocol for any kind of decision taken by the NEC.

## Agenda No. 2

The Committee was apprised of the OA on Cadre Review filed by the Association which has been admitted by the Court on 20<sup>th</sup> January, 2023. The change in the Applicant No. 2 of the Cadre Review case was also apprised to the Committee by the President, Shri Mathpal. He added stating that the physical copy of the OA is in the safe custody of Smt. Sreemati Bhowmik and scanned copy of which should not be shared anywhere, as this is the sole property of the lawyer. Any member, if interested can go through the physical copy of OA.

Apart from the above, Mahesh ji requested to seek advice from the lawyer as to what extent the Association can go and express the grievances. Shri Joshi explained that any advice from the lawyer will have financial implications and as such the issue may be referred to NEC for discussion.
