The Meeting was initiated by the Secretary General Shri P. M. Vishwamitra with the brief history and facts on the issue of Transfers and Postings which is being kept pending by CGA Office during the last 7 months. He invited the members who are waiting for their transfers to speak about their feelings, hopes, experiences and expectations in addition to the problems faced by them ever since their posting at an outstation.

and a few others who attended the meeting. All the members present in the meeting felt that:

- There is an abnormal delay in the matter of transfers and postings by the CGA Office.
- The guidelines of the "Transfer Policy" are not being followed in true spirit by CGA Office.
- Civil Service Boards, constituted by CGA Office, are being formed and cancelled by the CGA Office for the reasons best known to them.
- There is an undue delay in transfers and postings is causing extreme frustration, mental agony, distress and other sufferings to the officers who are expecting their transfers during the last one to two years.
- They are facing so many problems and so many losses on accounts their prevailing health conditions (BP, Diabetes, Tension, Mental agony causing sleepless nights etc.,), on account of financial loss (due to drop in emoluments, due to establishment and maintenance of their families at two places, due to withdrawal of Govt. quarters etc., and also on account of estranged human relations between the family members) etc.,
- They are visiting and scrolling the CGA Website every now and then to know and see about any updates about issuing of Transfer orders by the CGA Office,
- This is the time to take concrete action by the AICAOA to complain to the higher authorities for their immediate intervention in the matter.
- The Association as well as the individual officers should initiate necessary steps to bring the issue to the notice of the CGA and the higher authorities from time to time till the issue is resolved.

After a thorough deliberations and discussions in the meeting, on the issue of transfers and postings, the following plan of action was proposed:

- 01. To write an immediate letter to the CGA Office on this issue to expedite issuing the transfer and posting orders in a time bound manner, say, within a week and a maximum of 15 days.
- 02. To meet the CGA and the concerned authorities at the earliest possible (within 2 or 3 days) and to impress upon the immediate necessity for issuing transfer orders for which our President Shri H C Mathpal ji is deputed for this purpose by the NEC to meet the authorities and to give the feedback to the NEC for further plan of action in this regard.
- 03. To write letters to Cabinet Secretary, Secretary Expenditure and Secretary DOPT with a copy to CGA.
- 04. To bring the matter to the notice of the concerned MoS of Finance, DOPT etc.,
- 05. To bring the matter to the notice of the PMO and FMO.
- 06. To further plan and intensify and to show our resentment to the authorities in different ways before the Civil Accounts Day (1st March, 2023) by the NEC of AICAOA which will be decided in the next NEC Meeting.
- 07. Individual officers were advised to submit the reminders in respect of their pending transfers keeping in view of completion of tenure etc., and to request the CGA for issuing transfer orders at the earliest possible.
- 08. To register their Username and Password, at the first instance, for lodging their grievances in CPGRAMS portal, in future, if no orders are issued by the end of this month.

The meeting ended with a vote of thanks to all the members who attended the Meeting.
