MINUTES OF NEC MEETING

An online meeting of the "National Executive Committee" of AICAOA was held on 25th May' 2025 at 12:00 Noon on Google Meet to decide upon the next course of action in the matter of R.A. No. 152/2023 and O.A. No. 192/2023 regarding Cadre Review of Sr.AOs as Group 'A'.

Deliberations/ Decisions of NEC: The decision of CAT, PB, Delhi in R.A. No. 152/2023 was discussed and deliberated in detail in NEC Meeting. All the present members expressed their dissatisfaction and felt aggrieved by the decision of the Hon'ble CAT, PB, Delhi voicing strong disappointment and concern over its wider implications.

Further, it was unanimously decided to file a Writ Petition in the High Court of Delhi and a resolution was passed by NEC, AICAOA in the name of Ms. Geetanjali, President, AICAOA; authorising and empowering her to represent and deal on behalf of AICAOA and sign all the relevant documents/certificates etc., that are required to file a Writ Petition in the High Court of Delhi on the issue of "Challenging the decision of CAT, PB, New Delhi in R.A. No. 152/2023 and O.A. No. 192/2023".
