MINUTES OF NEC MEETING

A meeting of the "National Executive Committee" of AICAOA was held on $7^{\rm th}$ April' 2024 at 4 PM on Google Meet. Agenda points and decisions of NEC are as follows:

Agenda 1: Status of Case Filing of PAO to Sr. AO Promotion case in CAT, PB, Delhi on its remand back from Delhi High Court.

Deliberations/Decisions of NEC:

- 1. It was informed by Secretary General, AICAOA that he visited Delhi w.e.f. 01.04.2024 to 05.04.2024 as per resolution passed by NEC, AICAOA vide Minutes of Meeting dated 26.03.2024 and hired the same advocate (Shri Ankur Chhibber) for arguing PAO to Sr. AO Promotion case in CAT, PB, Delhi. Further, he added that he visited many offices viz. Health, UD, Commerce, CGA Office, PFMS etc. and carried out reconciliation work also with the help of Shri Rajeev Kumar, ASG. All the NEC members appreciated "the Team", which accompanied SG during his Delhi visit and accomplishment of task well in advance before listing of the case before Learned Registrar of the Learned Tribunal on 15th April' 2024.
- 2. While discussing the fresh fee (For arguing in CAT, Delhi) charged by Advocate and available bank balance of AICAOA, it was informed by FS, AICAOA that AICAOA is in deficit if we look into the current liabilities and current bank balance of AICAOA. He presented a chart of receipts and expenditure of AICAOA as on 07.04.2024 which is as below:

All such type of donations will be received in the one & only bank account only wherein monthly subscriptions from salary are received.

Agenda 2: Status of Collaboration with AIAPAO.

Deliberations/Decisions of NEC: It was informed by SG that AIAPAO has formed a Committee of 11 Members to look into the collaboration modalities and an online meeting of both the Committees (Comprising Members from AIAPAO and Members of AICAOA) is expected to be scheduled in the month of April' 24 itself.
