**MINUTES OF NEC MEETING**

A meeting of the "National Executive Committee" of AICAOA was held on 17<sup>th</sup> June' 2024 at 3:30 PM on Google Meet. Agenda points and decisions of NEC are as follows :

**Agenda 1: Discuss recent transfer orders of Sr. AOs issued from O/o CGA vide letters dated 14.06.2024 and decide stand of AICAOA in the matter.**

**Deliberations/Decisions of NEC:**

It was informed by Secretary General, AICAOA to all the NEC Members that he has received many calls from member Sr. AOs who informed that their transfer orders have been issued arbitrarily. Other NEC members also submitted that they have also received calls from many affected members. After due deliberations, it was decided unanimously that AICAOA will appeal all the affected members to represent to O/o CGA under endorsement to AICAOA. AICAOA will further escalate the matter to higher authorities regarding issuance of new Transfer Policy dated 12.02.2024 arbitrarily without dialogue with recognised service associations and violation of even that Transfer Policy also in transfer orders dated 14.06.2024.

**Agenda 2: Delay in granting promotion from Sr.AO to ACA as per existing Recruitment Rules and pay fixation under FR 22(1)(a)(1) to Sr.AOs joined on or after 26.04.23- Seeking legal recourse in both matters.**

**Deliberations/Decisions of NEC:**

After due deliberations, it was decided unanimously that AICAOA will seek legal recourse for legitimate rights of promotion from Sr.AOs to ACA as per existing Recruitment Rules and pay fixation under FR22(1)(a)(1) to Sr.AOs joined on or after 26.04.23 on their promotion. Chairman, Legal Committee, AICAOA is requested to take up both the matters on priority.
