MINUTES OF EMERGENCY NEC MEETING

Dated: 19th March, 2023

Consequent upon the issue of promotion order of AAO to AO vide Office Order No. K-18002/1/2022/Promotion/MF.CGA(A)/HR-III/Part-3/683 dated 17th March, 2023, there is a resentment among the members who are posted outside their home station and still not transferred, whereas a large number of newly promoted AOs have been adjusted in their home station vide the order dated 17th March, 2023 inspite of the fact that significant number of AOs are waiting for their turn to be transferred. To discuss the course of action by this Association and to address their grievances, an emergency NEC Meeting was held on 18th March, 2023 at 09:00 pm in the Google Meet platform.

Members present in the meeting expressed their views on the transfer/promotion order issued by O/o CGA on 17th March, 2023. All the members unanimously agreed that the said transfer/posting order is not in compliance with the Transfer Policy issued by O/o CGA. Members submitted that the latest Transfer Policy is the one issued by O/o CGA vide OM dated 30th October 2015 and subsequent amendments/modifications were carried over somewhere during the year 2016 and 2017. However, members felt that there is no strict policy regarding transfers of AOs on promotion and the decision is always at the discretion of the authorities. After detailed deliberations, following course of action has been decided to be taken:

- 1. Write a letter to O/o CGA on 20th March, 2023 w.r.t. the transfer / promotion order of AOs vide Office Order dated 17th March, 2023 seeking an urgent appointment to have one to one discussion on the instant transfer / promotion order and the grievances of the aggrieved members posted outside their home station awaiting for their transfers.
- 2. Write a letter to O/o CGA seeking clarification on the transfer/promotion order issued vide Order dt. 17th March, 2023 and highlighting the significant gaps in the existing transfer policy with the recommendation to review the Transfer Policy to make it more transparent and unambiguous. The letter will also convey the grievances of our outstation AOs/Sr.AOs who are awaiting their transfer to their home station. This task will take a week's time approximately.
- 3. Simultaneously, all the transfer orders will be traced out and keep them as repository for analysis and future reference, whenever required.
- 4. Aggrieved members will be requested to give a fresh representation referring to their earlier one endorsing a copy to this Association.

Apart from the above, Shri Joshi also suggested to go to High Court to issue the writ of **quo-warranto** against Office of CGA. On this, it was decided that the same can be considered based on the replies given by O/o CGA.
