MINUTES OF NEC MEETING HELD ON 21st MAY, 2023

A meeting of the "National Executive Committee" of AICAOA was held on 21st May, 2023 at 03:00 p.m. through Google Meet platform. In the absence of the President, the newly selected Secretary General, Shri Kaushal Mishra conducted the meeting, which was attended by the following members:

Following were the agenda of the meeting:

- 1. To discuss and decide our stand in respect of a proposal 'treatment of AAOs as direct entry'
- 2. To take up the issue of transfer/posting of Accounts Officers & Sr. Accounts Officers who are waiting for their transfers in their choice/home station with Office of CGA before any further order is issued.
- 3. To deliberate on reconciliation of existing members / membership drive.
- 4. To discuss on the 'Cadre Review' case.

Deliberations on Agenda No.1:

At the outset Smt. Sreemati Bhowmik, Addl. Secy. General welcomed Shri Kaushal Mishra, as the new Secretary General of AICAOA and requested him to start the meeting. Shri Kaushal Mishra after expressing his gratitude started the meeting. First of all he explained the genesis of Agenda No.1 'treatment of AAOs as Direct Entry'. He informed that since last few days he is getting phone calls from an Executive Member of AIPAO (old Association of AOs/Sr.AOs) with a proposal of filing court case regarding 'treatment of AAOs of CCAS as Direct Entry'. The Executive Member of AIPAO proposed to file the case along with AICAOA and AAOs (Recognised) Association. Shri Mishra assured the AIPAO member that he will revert to him after deliberating the issue in NEC, AICAOA. Hence the agenda.

There were lots of deliberations in this regard and different views were shared by the members. It was felt by most of the members that there will be a huge coordination problem if the case is filed jointly by all the three associations. Further, AICAOA has already filed two important cases since its recognition of four months. Getting involved in more cases may impact the cases in hand. Necessity was also felt to revive the case of 'Cadre Review', verdict on which has already been given. Under these circumstances, the first thing to decide was whether to file the case jointly i.e. be one of the applicant in the case or to support from outside. Members were of different views as regard to giving financial support from outside. Few members questioned on the merit of the case. Some were of the view of creating a **Coordination Committee** which will include selected members of the all the three association for coordination purpose, if the association decide to move to the court jointly.

Finally, with the consent of all the members, it was decided to have a meeting with representatives of AIPAO and AAO (Recognised) Association to understand the issue & readiness and to arrive at a consensus. The decision taken during any such meeting will be referred to the Legal Committee of AICAOA who will assess the merit of the case and other pros and cons of giving any kind of support from inside (to turn as a party)/outside (Financial/ Legal Support) or to remain aloof.

Deliberations on Agenda No. 2

Second agenda was to discuss the course of action by AICAOA on transfer of senior AOs/Sr.AOs to their home station. After deliberations, it was decided to draft a detailed letter with reference to the letter given by AICAOA earlier in this regard and send it to O/o CGA by Wednesday (24th May, 2023) and meet the concerned Jt.CGA on the following day i.e. 25th May 2023, Thursday (as per schedule).

Deliberations on Agenda No. 3

In this regard, Shri Kaushal Mishra expressed his deep concern on the gradual reduction in the subscription amount as is evident from the bank statement. Reconciliation and ensuring deduction of subscription has become very important at this stage. Shri Subhash Chand stated that reconciliation will not be possible with the pay-slip alone. It will infact be possible if UTR No. For deduction is provided by the members. Smt. Anita Rawat threw some light on the reconciliation process done in the previous occasion alongwith Shri Vishwamitra and Shri Subhash Chand. With this, it was decided that the reconciliation will be done with the same process under the guidance of Smt. Anita Rawat, Vice-President & Shri Shubhash Chand, Finance Secretary.

Shri Kaushal Mishra stressed upon formation of Zonal Branches as decided earlier in line of constitution and by-laws of AICAOA. To which, all present members unanimously supported and it was decided that Shri Rajiv Kumar and Shri Kaushal Mishra both will complete the formation of Zonal Branches (except to Delhi) as per "Road Map for Formation of Zonal Branches vis-a-vis Membership Drive".

Deliberations on Agenda No. 4

The Cadre Review case file by AICAOA (OA 192/2023) has been disposed of by the CAT in its hearing on 24th February with an ambiguous decision. It has been strongly felt by all the members to take corrective steps to revive. Shri U.C. Joshi, suggested to discuss the issue once again with the advocate and seek his comments on the judgement of the case. Shri Joshi highlighted CGA's proposal of induction of SrAOs at Level-11 and rejection of the same by MoF on grounds which are inconsistent with the cadre structure. **After deliberations, it was decided that Legal Committee will explore further legal course to be taken up in matter of Cadre Review.**

The meeting ended with a vote of thanks to all the members who attended the Meeting.
