#### Discussion on Agenda No. 1:

All the members present in the meeting shared their views on the proposed draft transfer policy issued by the O/o CGA. After detailed deliberations it was decided to convey the views/comments of AICAOA

**Discussion on Agenda No. 2:**

The Secretary General, Shri Kaushal Mishra apprised all the members present in the meeting about the status of both the court cases being filed by AICAOA as follows:

- (i) Writ Petition for the case of promotion of AO to Sr.AO has been admitted in High Court with the next date of hearing as 13<sup>th</sup> March 2024.
- (ii) As per the directions of Delhi High Court, the case for Cadre Review was filed for review petition in CAT, Prinicpal Bench. The same is in the process of listing.

**Discussion on Agenda No. 3:**

It was unanimously decided that a reminder letter would be sent to CGA seeking a comprehensive illustration of pay fixation cases in respect of all the AOs (at Level-9) who has been merged at Level-10 and re-designated as Sr.AO by virtue of merging order by CGA and all those who have been promoted as Sr.AOs after the effective date of merger order to ensure uniformity and avoid anomalies.

**Discussion on Agenda No. 4:**

With regard to the open letter from ex-SG, the present SG Shri Kaushal Mishra, taking moral responsibility of the concern raised, expressed his willingness to relinquish his charge till further decision is taken. However, it was unanimously felt and decided by the members present in the meeting that the issue needs to be discussed under the chair of the President. Since President (AICAOA) did not attend the meeting, it was decided that let Shri Kaushal Mishra continue carrying the charge of SG till any further decision is taken in this regard as he has been co-opted from within the National Executives by voice vote of NEC. The Addl.SG assured that she will convey the concern raised by the ex-SG to the President and will convene a meeting soon in this regard.
