Agenda No.1 "Discussion on Status of Cadre Review Case":

NEC Members of AICAOA discussed in detail about filing of Writ Petition in Delhi High Court in r/o Cadre Review Case and were apprised by Addl. Secretary General that matter has been taken up with lawyer on priority. Lawyer has asked some supporting documents/informations, which are being collected. All NEC members felt satisfied with the developments in job of filing of Writ Petition in Delhi High Court.

Agenda No. 2 "Course of Action by AICAOA after issuance of PAO and Sr.AO Merger Orders by O/o CGA":

The agenda point was deliberated in detail. All NEC Members submitted their views on the matter. After considering all comments and after a detailed discussion, it was approved

- 1) Conduction of DPC for promotion of eligible PAOs as Sr. AO retrospectively for the year 2019, 2020, 2021, 2022 & 2023, as many AAOs have been promoted recently to the post of Sr. AO after 26.04.2023.
- 2) To avoid any anomaly in pay fixation, O/o CGA will be requested to issue an illustrative pay fixation OM with examples covering all possible pay fixation cases arising due to upgradation and Merger of PAO (L9) with Sr. AO (L10-Group A).

Agenda No. 3 “Reminder to O/o CGA regarding issuance of Transfer Policy”:

The agenda was deliberated in large during the NEC meeting and it was decided unanimously to write a letter to O/o CGA for finalization of Transfer Policy considering suggestions given by AICAOA at the earliest.

Agenda No. 4 “Decision on resolution of AAO Association for merging of AAO Association and AICAOA”:

Detailed deliberation was made during NEC Meeting w.r.t. resolution passed by AAO Association to merge and form a single Officers association from AAO to Sr. AO to strengthen the unity and power of officers. All the NEC members appreciated and welcomed the move and decision taken by All India Civil Accounts Gr. ‘B’ Gazetted (Assistant Accounts Officers) Association. Further, NEC of AICAOA unanimously passed that AICAOA will keep maintaining a strong mutual understanding with AAO Association and further suggests to form co-ordination committee on case to case basis as and when required.

Agenda No. 5 “Formulation of Code of Conduct for Members of AICAOA”:

All members agreed that there is no need of formulation of Code of Conduct since all members are Group-A and understands responsibility of their behavior on social platforms. However. it was stressed upon that any message other than cadre related issues will not be encouraged and welcomed in AICAOA Whatsapp Group. Moreover, messages other than cadre related issues may be posted at “I, YOU & OUR COLLEAGUES Whatsapp Group”.

Agenda No. 6 “Formation of Co-Ordination (CDN) Committee and inclusion of some members in Legal Committee of AICAOA”:

A. Keeping in view the transfer requests and other administrative issues of members, formation of a Co-ordination Committee (CDN Committee) was approved unanimously by NEC of AICAOA to look into above referred issues of members. Members of the Committee are as below:

2. AICAOA will write a letter to O/o CGA to issue an illustrative pay fixation OM with examples covering all possible pay fixation cases arising due to upgradation and Merger of PAO (L9) with Sr. AO (L10-Group A) before 26.04.2023 and after 26.04.2023.
3. AICAOA will write a letter to O/o CGA for finalization of Transfer Policy in line of suggestions given by AICAOA at the earliest.
4. AICAOA will keep maintaining a strong mutual understanding with All India Civil Accounts Gr. 'B' Gazetted (Assistant Accounts Officers) Association and further suggests to form co-ordination committee on case to case basis as and when required.
