MINUTES OF NEC MEETING

An online meeting of the "National Executive Committee" of AICAOA was held on 14th December' 2024 at 3:30 PM on Google Meet. Agenda points and decisions of NEC are as follows :

Agenda 1: Status of Ongoing Court Cases:

Deliberations/ Decisions of NEC: Shri Kaushal Mishra, Secretary General and Sh. U.C. Joshi, Chairman Legal Committee presented the status of ongoing court cases before NEC. After due deliberations following decisions were taken unanimously:

3.	Pay fixation under FR 221(A)(1). (O.A. No. 532/2024)	Respondent's advocate has not yet filed reply. NDOH- 23.12.2024.	NEC decided to file M.A. for Ex-parte against respondents and hear the case on merits. Since now, M.A. in both the cases has been filed in CAT, Lucknow Bench.

Agenda 2: Formation of a delegation to meet Jt. CGA (HR) in pursuance of action taken by O/o CGA on different points discussed during meeting dated 24.10.2024.

Deliberations/Decisions of NEC:

A meeting under the Chairmanship of CGA with NEC of AICAOA was held on 24.10.2024 to discuss different agenda items. Minutes of Meeting was issued by O/o CGA vide F. no. A-23006/2/2020-NGE-CGA/446 dated 05.11.2024 (copy enclosed). Since then, considerable time has lapsed. The agenda item was discussed in detail and it was decided unanimously that a delegation of AICAOA will take appointment of Jt. Agenda 3: Amalgamation with AIAPAO (C) Association:

Deliberations/Decisions of NEC:

Agenda item was deliberated upon and all the NEC members were informed that proposal of Amalgamation of AIPAO (C) with AICAOA is in active consideration of AIPAO(C). It was stressed upon by all the NEC members and decided unanimously that AICAOA will stick to the last date of winding up this issues by 31st March' 2025 as decided in NEC Meeting dated 23.11.2024.

Agenda 4: Status of formation of Delhi Zonal Branches:

Deliberations/Decisions of NEC:

Constitution and Bye-Laws of AICAOA provisions formation of 4 Zones within Delhi keeping in view the sanctioned strength of Sr. AOs at Delhi. Approx. 615 posts are sanctioned in Delhi which is almost 50% of Total Sanctioned strength of Sr. AOs. Many interested members who volunteered to share the responsibilities in Delhi Zone as delhi delegates were shortlisted during GBM on 14.11.2024. A meeting with these members have already been conducted by NEC. Further, it was decided unanimously to hold a meeting of Delhi delegates with NEC on 15.12.2024 and form the Delhi Zonal Branches amongst the interested members.

Agenda 4: Any other issue with permission of Chair.

Deliberations/Decisions of NEC:

Issue of treatment of AAOs as direct entry, in line with provision in C&AG; was raised by the Secretary General with the permission of Vice-President. After due deliberations, it was decided unanimously to refer the matter to Legal Committee to examine and advice NEC future course of action.
