I am writing on behalf of the All India Civil Accounts Officers (Sr. AOs & PAOs) Association (AICAOA) to once again request your esteemed office for an appointment to convene a team meeting. Our aim is to engage in a constructive dialogue regarding various cadre-related matters that have been pending since long.

We would like to draw your attention to our earlier correspondences in this regard vide letter no. AICAOA/NEC Meeting/2022-23/73 dated 24.03.2023, even no. 85 dated 22.06.2023 and letter no. AICAOA/NEC/2023-24/113 dated 21.01.2024. Despite our consistent efforts to initiate discussions on various cadre-related matters that have been pending since long, we regret to note that no appointment for a meeting has been forthcoming from your end.

In addition, we would like to remind you last meeting between National Executive Members of Service Associations and official side of O/o CGA held on 21.02.2023 at 5:00 PM in Swasti, O/o CGA, INA, New Delhi, Chaired by the then Controller General of Accounts. Minutes of Meeting against meeting dated 21.02.2023 was issued vide your office letter F. No. A-23006/2/2020-NGE-CGA/517 to 523 dated 22.03.2023. In this letter, there was a clear commitment from the official side (O/o CGA) to engage in regular meetings with the aim of fostering a congenial atmosphere conducive to addressing the concerns of the CCAS Cadre. It is not understood that what was the need to agreeing with staff side for regular meeting when official side is not responding to requests of recognised service association or how much months/years are required for next regular meeting?

Regrettably, despite the passage of more than a year and numerous requests from our side, no progress has been made in scheduling a meeting to address crucial cadre related matters. The lack of engagement has only served to exacerbate the challenges faced by Senior Accounts Officers within the cadre.

Therefore, we earnestly request your cooperation in facilitating an appointment for a team meeting at your earliest convenience. We believe that open dialogue and collaboration are essential in resolving the issues faced by our members and ensuring a harmonious working environment.
